Ideas are sourced widely and screened using quantitative and valuation analysis.

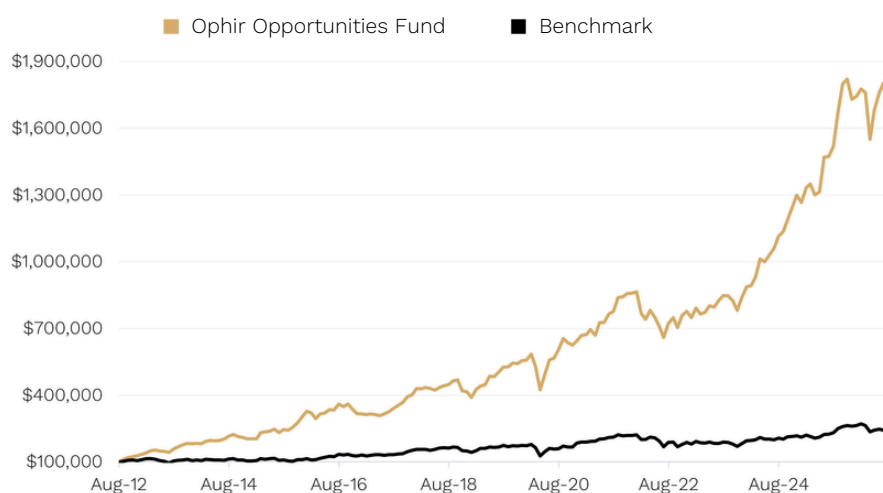
